Monitoring Report

A. Purpose of Visit: The purpose of the visit was to monitor the Support provided to the Hospital (Sifwat Ghayour Memorial Hospital) to assess the availability and functionality of provided support including Medicines, equipment's and Janitorial Services to ensure that the required services are available and effectively utilized.

After a short introductory meeting with the Medical Superintendent Dr. Rafiq Hayat which has recently joined the Hospital who greatly appreciated the support provided by the KP HCIP and termed that the Project has really made a difference in the performance of the Hospital with respect to DHIS-2 Tools, Communication Tool i.e LEDs, Supply of medicines, equipment's, furniture's and especially the Security and Janitorial Services

B. Equipment and Furnitures

During the visit, Store Keeper of the Hospital facilitated the team in visiting various sections of the Hospital where the Project has provided support. The team physically checked the installation of all items as per the below detailed list:

C. Description of Medicines Availability: The team only checked the medicines supply during the last 2 days, as other items have already been inspected by the team a week back.

D. Medicine Store: The medicines provided by the Project were monitored stocked in a 4 different places due to lack of proper and suitable store facility at the Hospital. The medicines have been stocked at a small and congested medicine store, some have been stored at the Girls Hostel while even some have been stocked at the Car Parking slot reserved for the MS of the Hospital. The issue was raised and discussed with the MS, who is quite determined to make arrangement for a suitable and enough place for stocking the medicines in a side building occupied by the RESCUE 112, which is not used by for any purpose.

E. Meeting with Medical Superintendent (MS)

During the visit, M&E team also met again after the visit with the Medical Superintendent (MS) and continued discussion that how the Hospital performance can be further improved. The MS shared several requests, provided a demand list of Medicines and equipment/ Machinery for the hospital and suggestions to improve health service delivery, which are summarized below:

1. Establishment of a CEmONC Facility

The MS highlighted the need for a Comprehensive Emergency Obstetric and Newborn Care (CEmONC) facility to address critical maternal and child mortality cases. He added that being a single facility of its nature in the area and even in Peshawar, the Hospital has enough building and Infrastructure for the proposed CEmONC and they get the required Technical support, it could easily lead them to a Women and Children Hospital.

2. Support for Health Care Services

The MS requested support in improving overall health care services at the facility.

3. Medical Supplies

The Hospital Administration specifically requested the following:

- 1. Provision of IV Cannula 24G instead of the IV Cannula 22G currently available.
- 2. Provision of 1*5 yard Adhesive tape instead of 3*5 or 4*5 yard Adhesive tape
- 3. Provision of Drip Sets
- 4. Provision of the medicines: **Annex-A**

4. Human Resources

The MS pointed out that the Security and Janitorial services provided by the KP HCIP had a very good impact as far as Security and Janitorial services are concerned. He added that a visual difference has been noticed since the services have been cut off resulting into lack of security and cleanliness. He once again requested the support may please be resumed, which can certainly add to the better performance of the Hospital.

F. Observations and Recommendations

- The inspected equipment was found present and functional as per the assigned requirements.
- The hospital administration has expressed genuine needs regarding maternal and child health care, particularly in establishing CEmONC services.
- Consideration may be given to providing 24-gauge cannulas and deploying additional support staff.
- It is recommended to review the quality standards of the equipment and materials supplied to ensure they meet hospital requirements and are of acceptable durability.
- For proper repair of the damaged Beds and Lockers, the Performance Contract/ Contract Agreement of the Supplier may please checked and if possible, rectification could be done. In other case, the PMU may see the case to find a better solution for recovery or repair of the damaged Furniture/Beds, Lockers and Trolleys

G. Conclusion

The visit to Sifwat Ghayour Memorial Hospital confirmed that the necessary equipment is available and functional, with appreciation for the support provided by the KP-HCIP in the form of ICU equipment. However, the MS highlighted critical gaps in maternal and child health care services, requested improvements in medical supplies and staffing, and emphasized the need to ensure better quality of the provided equipment and materials. These concerns may be reviewed for possible action to strengthen health care delivery in the hospital.

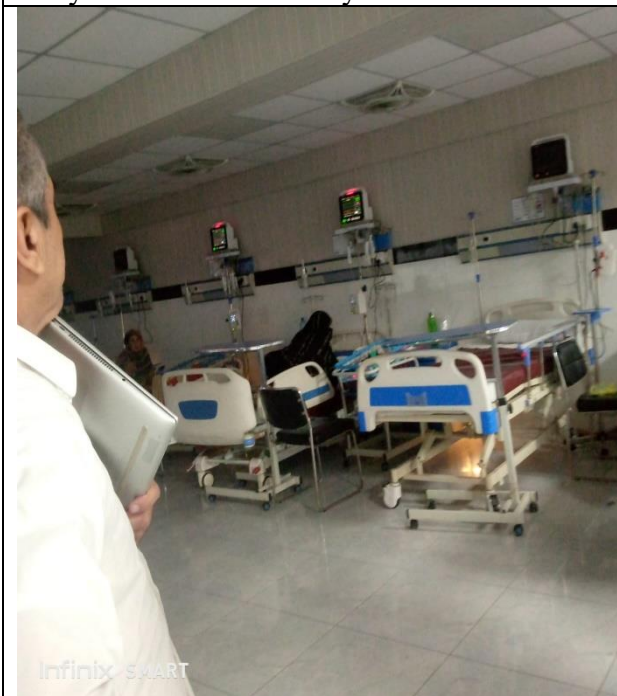
